

To sign-up for automatic/recurring payments with a debit or credit card, simply login to your customer account at our new web portal (https://pinerywater.epayub.com) and enter your debit or credit card information in the 'Auto Pay' section of your account settings. This is the same process for entering ACH/automatic payment information using a checking or savings account at our web portal as well.

The District is also happy to announce that we can accept electronic bill pay payments through customers' financial institutions which is typically free for customers to use. These payments are loaded into our billing systems payment portal for quick and easy electronic processing, making it a safe and smooth transaction for all.
