From your board of directors

In previous newsletters, it was pointed out the District has in-ground assets totaling millions of dollars to handle waste water collection and provide quality water service. Maintaining those assets for today and future generations is an important task for the District.

Three years ago, the District implemented a Strategic Asset Management Implementation Plan to proactively maintain the District's assets. The goal is to extend the life of the District's assets while reducing failures of the equipment and costly emergency repairs. A large component of this asset management program is to replace the oldest pipes most impacted by breaks and leaks.

The District is currently replacing sections of pipeline on three streets in the Pinery community: Huggins Court, Windlawn Way, and Thunderbird Road. Construction began late May and will continue through the summer wrapping up sometime in October.

Smart Metering

We are starting to see those summer temperatures creep up! With those temperatures rising so will your water usage. How would you like to be able to see what your daily usage is in the palm of your hands? In 2018, Pinery Water started offering a “*Smart Metering*” option for our customers. By choosing this option you will be able to monitor your water usage from the palm of your hand or a click of a mouse. This allows you to better understand your consumption pattern and help save you money on your summer watering. Below is some more information about the “Smart Metering” option. EyeOnWater® Advanced Metering Program enables customers to view and understand water usage profile through an easy-to-understand consumption graph and provides a simple method to establish alerts to better manage your water use. This tool literally puts water usage data in the palm of your hands. EyeOnWater mobile apps bring the power of the online portal to your iOS device or Android smartphone.

Features:

- Hourly, daily, monthly, and yearly data and charts
- Temperature and precipitation overlays
- Week-over-week consumption comparisons
- Configurable leak alerts by email or SMS text
- Web-based consumer portal, plus Android and iOS mobile apps.

Cost:

Customer pays \$206, this covers the activation and administration fees. The \$206 will be added to your water account or there is the option to pay separately by check or cash at the district office. Inquire about monthly installments. In addition, there is a \$0.91 monthly data fee. The *EyeOnWater* app is a free download. Any home that was built in 2018 and after has the smart meter installed so there is no start up fee.

Annual Water Quality Report
